

#### **NEW STRATEGIC DRIVER**

Could there be something more, to impress a need for an organization like CAPE, than the ever-growing, but unrewarded presence in Canada of the immigrants with engineering backgrounds? CAPE whose aim has been



to promote recognition and utilization of the large pool of skills that these immigrants have brought to Canada, at its own behest! Isn't it unfortunate that these immigrants have largely been locked out of the opportunities they may have otherwise deserved?

A lot of the reasons why immigrant engineers have found it so incredibly hard to integrate their knowledge, skills and experience in the Canadian labor market are well-known and much of what is known today has been due to CAPE's own research over the last few years. That has been the backbone of CAPE's advocacy effort. Last year, our membership mandated us to add vigor to this advocacy by initiating active community engagement. As a result, we engaged in constructive, intimate conversations with our members at several town-hall

meetings held at major civic centers across the GTA. These have reinforced some of our findings and given us thoughts for new directions, especially employment and advocacy, which undoubtedly remains our most critical need.

As a direct result of this investigation, CAPE has measured the intolerable waste of your skills and knowledge -CAPE estimates a loss of a guarter billion dollars (in cost of education) and \$115 million annually (in loss of earnings) for our 3,240 members alone. We must break the thirty year trend of being locked out of our profession. Starting 2011, CAPE will exploit all avenues of advocacy including working at the grassroots levels with the CAPE membership, community coalition and concerns advisory resources; voicing your to politicians/policy makers; and setting up a fund for legal action. As CAPE moves to strengthen its new strategic driver - Citizenship and Advocacy -it will need to find innovative ways to support and sustain our organization drawing upon your support.

#### CURRENT STATE OF FOREIGN CREDENTIAL RECOGNITION IN CANADA

 CEAB recommends that Engineers Canada's constituent members treat graduates of programs evaluated as substantially equivalent like graduates of Canadian Engineering Accreditation Board-accredited programs for the period that substantial equivalence is in effect.

- But:
  - Since 1997, 5 institutions in 4 countries (insignificant number) have been granted substantial equivalency including:
  - Mutual Recognition Agreements (MRAs) that have been signed by Engineers Canada with only 11 national and international organizations



Key findings from it community action research projects over the last four years were presented at the CAPE knowledge event 2010.
